1. Bhagwanpur Rural Municipality has allocated funds towards the cost of Construction of Healthpost & Ward Office Building and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Healthpost & Ward Office Building, Contract ID: BRM/1/078-79. Bidding is open to all eligible as per Section V of bidding document.
2. Office of Rural Municipal Executive, Bhagwanpur Rural Municipality invites electronic bids from eligible bidders for the Construction of Healthpost & Ward Office Building under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders having key qualifications as per Section III : Evaluation & Qualification Criteria should participate in this bidding:
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Bhagwanpur Rural Municipality, Siraha or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. A complete set of Bidding Documents can be downloaded from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document of NRs. 5000.00 in the Project's Rajaswa (revenue) account as specified below till 17 Sep 2021 during office hour .

6. Pre-bid meeting shall be held at Office of Rural Municipal Executive, Bhagwanpur at 14:00 on 03 Sep 2021.
7. Electronic bids must be submitted to the office of Rural Municipal Executive, Bhagwanpur through PPMO's e-GP system www.bolpatra.gov.np/egpon or before 12:00 on 18 Sep 2021. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 18 Sep 2021 at the office of Office of Rural Municipal Executive, Bhagwanpur. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs.13,00,000.00, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit Account No. 0362056500002003 (Dharauti Khata), Bhagwanpur Municipality, Bankers name: NIC Asia Bank Ltd. Lahan Branch and deposit voucher along with the bid. Bidder can also submit bid security in the form of bank guarantee from A class commercial bank or financial company.

8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid
