1. Bhagwanpur Rural Municipality **has allocated funds** towards the cost of **Construction of Balan Khola Trail Bridge** and intends to apply part of the funds to cover eligible payments under the Contract **for Supply, Fabrication, Transportation, Erection & Construction of Balan Khola Trail Bridge, Contract ID: 2/076-77**. Bidding is open to all eligible as per Section V of bidding document.
2. **Office of Rural Municipal Executive, Bhagwanpur Rural Municipality** invites electronic bids from eligible bidders for the **Construction of Balan Khola Trail Bridge** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. The details of Qualification requirement are stated in Section III: Evaluation & Qualification Requirement.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Bhagwanpur Rural Municipality, Siraha** or may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
5. A complete set of Bidding Documents can be downloaded from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document of NRs. 5000.00 in the Project's Rajaswa (revenue) account as specified below till 2077/03/10 (24 June 2020) during office hour .

6. Pre-bid meeting shall be held at **Office of Rural Municipal Executive, Bhagwanpur** at **14:00 on 09 June 2020**.
7. Electronic bids must be submitted to the office **of Rural Municipal Executive, Bhagwanpur** through PPMO's e-GP system [www.bolpatra.gov.np/egpon](http://www.bolpatra.gov.np/egpon) or before **12:00** on **2077/03/11 (25 June 2020)**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 on 2077/03/11 (25 June 2020)** at the office of **Office of Rural Municipal Executive, Bhagwanpur**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs.9,50,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
9. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit Account No. **0362056500002003 (Dharauti Khata), Bhagwanpur Municipality, Bankers name: NIC Asia Bank Ltd. Lahan Branch** and deposit voucher along with the bid. Bidder can also submit bid security in the form of bank guarantee from A class commercial bank or financial company.
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
11. In the case of discrepancies or error in bid documents, bid notice or any other document, the Municipality reserves the right to amend and correct at any time.
12. The Municipality reserves the right to accept or reject the bids without assigning any reason whatsoever.
